Dear Parents

This is for your kind information that as per interim directions of Hon'ble Supreme Court Order dated 08.02.21, school has to collect 100% school fee for the session 2020-21. Our school has kept the same fee as 2019-20 without any increase. The honorable court also has given a relaxation to parents who are not able to pay the fee all at once. They can pay in six installments with the first installment being due on 05th March 21 and thereafter in five equal installments to be payable on or before the 05th of every month. The Management has offered the following discounted fee:-

Fee payable for the month of Mar and Apr, can be deposited online through the payment gateway on the school website or in the school office by cheque during the school hours.


